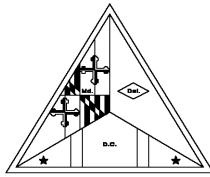

- SOUTH FROM BALTIMORE OR NORTH FROM WASHINGTON TO 695 (BALTO. BELTWAY)
- TAKE THE BELTWAY (I 695) TOWARD GLEN BURNIE. EXIT BELTWAY ONTO RT. 97 TOWARD ANNAPOLIS
- EXIT RT. 97 AT EXIT #16 ONTO RT. 648 (BALTO – ANNAPOLIS BLVD.)
- TAKE 648 NORTH TOWARD LINTHICUM, PROCEED APPROX. ½ MILE
- TURN LEFT ONTO FERNDALE RD. AND MAKE AN IMMEDIATE LEFT ONTO BROADVIEW BLVD.
- FIRE HOUSE IS ON THE LEFT AND THE HALL IS IN THE REAR
